CHILDREN & FAMILIES

The Childcare Payments Bill had its second reading in July and is now at the committee stage in the house of commons. It aims to introduce a new tax-free childcare scheme to support eligible parents with childcare costs.

EMPLOYMENT

The Institute of Public Policy Research, have proposed that the £1.2bn Work Programme, the government's flagship welfare to work scheme, needs to be broken up in the face of figures showing that as little as 5 per cent of unemployed people on the main disability benefit are finding a job through it.

On the Work Programme, the report concludes that the scheme is failing mentally ill people in particular; and adds that the task of helping those on Employment Support Allowance – the main disability benefit – to find work should be devolved to local authorities, with councils recouping some of the possible savings from the Department for Work and Pensions.
