## CHILDREN & FAMILIES

September saw the **introduction of the Government initiative to expand free childcare** with the aim of doubling the number of disadvantaged two-year-olds eligible to receive 15 hours of free care a week from 130,000 to 260,000.

Childminder agencies also begin operating. Individual childminders will no longer have to be inspected by Ofsted, which will instead assess the quality of agencies.

Hundreds of thousands of **stay-at-home mothers will be encouraged to go to work** under Government plans to reform childcare in the UK. George Osborne, the Chancellor, wants to see nearly 500,000 more women in the workplace by the beginning of 2016.

An **expansion of the Troubled Families initiative** is to focus on tackling poor health and supporting children under the age of five, the Department for Communities and Local Government (DCLG) has revealed. This will include a heightened focus on tackling domestic violence, reducing debt and supporting children at risk of being taken into care as well as retaining a focus on reducing truancy, crime and antisocial behaviour. This follows the government's pledge to increase the number of families receiving intensive government support to turn their lives around from 120,000 to 500,000.

The Government is calling on **nurseries and other childcare workers to do more to help children from disadvantaged areas** to learn

The statistics show that overall 60% of children aged 5 are making good progress against the early years foundation stage profile (EYFSP). However, the gap between those from the most disadvantaged areas and their peers has remained static at 12%.

The EYFSP is designed to ensure that all children are prepared and ready for school and life in modern Britain. It measures things like how children play together through to being able to count to 10 and write their own name.

Early years professionals look set to play a key role in **improving the literacy of disadvantaged children** as part of a new national campaign to boost reading standards. A coalition of organisations wants all five-year-olds to be reading well by 2020.

The Read On. Get On campaign aims to get all 11-year-olds reading well by 2025 and is backed by a report that finds four in 10 disadvantaged children are not reading well by the time they finish primary school, almost double the rate for children from more affluent backgrounds.

Research shows that a **pre-schooled child has more chance of getting better exam results** and ultimately earning higher wages. The Effective Pre-School, Primary and Secondary (EPPSE) research shows children who go to pre-school are projected to earn £27,000 more during their career than those who don't. They are also more likely to get better GCSE results - the equivalent of getting 7 Bs compared to 7 Cs.

**Spending on children's centres and early years services has been slashed** by more than £400m in the space of just three years, government figures show.

Latest Department for Education (DfE) statistics reveal that councils have earmarked a total of £985.3m for Sure Start children's centres and early years services in 2014/15. That compares with £1,093.2m last year, a drop of £107.9m in 12 months, and a drop of £413.2m from the £1,398.5m that was forecast to be spent in 2011/12.

## **CRIMINAL JUSTICE**

There were more than **two million fewer crimes** in the past year compared with 2010, according to the independent Crime Survey for England and Wales. A decline in heroin use, unrecorded cybercrime and greater civility are among the reasons suggested for the drop. However, hate crimes are up 5% on the last year...so much for the civility theory.

## **DISABILITY**

**MPs have called for the scrapping of the work capability assessment** used to decide disabled people's eligibility for employment and support allowance. The Work and Pensions Select Committee found that eligibility tests for benefits are inaccurate and system fails to help claimants back into work.

There is also a commitment to tailor inspections to the issues that matter to people using substance misuse services.

There were approximately **230,000 more drug users in 2013/14** than the year before, according to Home Office data used in the Crime Survey for England and Wales. Male drug misuse deaths involving illegal drugs rose by 23 per cent, from 1,177 in 2012 to 1,444, while female deaths were up by 12 per cent to 513. The upward trend is in contrast to Scotland, which saw deaths fall by 9 per cent over the same period

A national **campaign to raise awareness of the dangers of new psychoactive substances** (NPS) – so-called 'legal' highs – among teenagers and young adults has been launched by the Home Office. This comes at the same time as a Royal College of Psychiatrists report suggesting that the scale of the new psychoactive substances problem may be greater than estimated, with services ill equipped to cope.

## **EMPLOYMENT**

**The DWP has set out its commissioning strategy for 2014**, outlining how it will work with providers and partners to deliver welfare to work services. The strategy largely reiterates that of 2008, with some additional references to using more innovative commissioning models for specialist provision.

At the same time the National Council for Voluntary Organisations has called for a major overhaul in the way welfare-to-work schemes are designed and paid for. The report argues that the Work Programme is not helping those with multiple or complex barriers, and voluntary organisations are well placed to provide support for those who are furthest from the labour market.

The future strength and stability of the UK economy is "under threat" as there has been a **long-term shift towards insecure, low-paying employment in many cities** across the country, according to thinktank the Centre for Cities.

A recent report, supported by the Joseph Rowntree Foundation, revealed the number of Britons employed in low-pay positions in UK cities jumped by more than 750,000 between 2001 and 2011.

**People claiming benefits will be expected to undergo attitude tests** to assess if they have a psychological resistance to work under new plans revealed by the employment minister. Esther McVey said benefit claimants will be profiled to see if they feel "determined", "bewildered" or "despondent" at the prospect of employment.

A pilot of the scheme is already happening at three job centres in the UK. If successful, a voluntary trial involving jobseekers from across 27 cities could commence to see if the scheme can predict whether someone will take work.

More than 90,000 **more young women than men are out of education, employment and training**. According to the latest figures, 418,000 women aged 18-24 compared with 325,000 men are considered NEET.

A report by the Young Women's Trust finds that the impact of being NEET for a woman is more significant and can last longer, with evidence showing that young women are NEET for longer than men – three years on average, versus two.

There were 3,020 families with children in either hostels or women's refuges during the first quarter of 2014, the latest Department for Communities and Local Government temporary accommodation figures show.

Landlords in the West Midlands are to be the guinea pigs for **immigration status checks on new tenants from December**. They will pilot area 'Right to rent' checks, which are a new measure introduced by the Immigration Act 2014. After the six months, the Government will decide whether to extend it to other areas. Guidance on the penalties landlords could face if they fail to do the checks were published on the government website but then removed. Homeless campaign groups have already raised fears that it will make it even more difficult for homeless people to find a place to live.

A report by the Independent Family Returns Panel found that between April 2012 and March 2014, 242 out of the 649 families with children that were identified as illegal immigrants and set to be returned to their home country were not pursued for deportation by the Home Office.

Financial support for families seeking asylum in the UK has been frozen since April 2011. As a result, asylum seekers have faced a 7.5% cut in real terms as a result of rising costs for food, clothing, and other basic necessities over the past three years.

## **MENTAL HEALTH**

The Deputy Prime Minister, Nick Clegg, has announced that treatment for mental health conditions will be brought into line with other NHS services with the introduction of the **first ever waiting time standards**.

For the first time, from April 2015, most patients needing talking therapies – for conditions like depression – will be guaranteed the treatment they need in as little as 6 weeks, with a maximum wait of 18 weeks. There will also be £120 million to improve mental health services.

The We Need to Talk coalition has found that a **significant number of people are waiting unacceptable amounts of time for treatment**.

An online survey of more than 2,000 people who had tried to access therapy in the past two years found that one in 10 had waited over a year between referral and assessment, while 41% had waited more than three months.

## **POVERTY**

Research by the Institute for Fiscal Studies (IFS) shows that **high housing costs made a significant contribution** to pushing 14.6 million people (23.2% of the population) into absolute poverty in the UK in 2012-13. The IFS forecasts that 2.5 million more people could be in poverty by 2020 unless a joined-up coordinated approach is taken.

Low wages, benefits cuts and the rising cost of raising children are leaving **full-time working families struggling to afford a basic standard of living**, a report by the Child Poverty Action Group (CPAG) has found. The report, *Cost of a Child in 2014*, which was funded by the Joseph Rowntree Foundation, found the income of families in full-time jobs at the national minimum wage is 18 per cent short of the basic amount needed to achieve a minimum standard of living. For those out of work the shortfall is 43 per cent, according to the report that says the cost of raising a child has risen by eight per cent since 2012 for a couple and 11 per cent for lone parents.

Britain is the only country in the G7 group of leading economies where **inequality has increased this century**, according to the annual Credit Suisse global wealth report. The amount of the country's wealth controlled by the richest 10% increased to 54.1% this year, up from 51.5% in 2000.

New JSA claimants will have to wait a full week to make a claim, rather than the current 3 days. This change will save £50m from welfare spending next year.

The Independent reports accusations aimed at government ministers of **pushing 300,000 people to pay day lenders** as these benefit changes come into force.

In the Government's social security advisory committee impact assessment it was found that 280,000 new recipients of Jobseekers' Allowance (JSA) and Employment and Support Allowance (ESA) will bear the brunt of the cuts. It calculated that JSA claimants would lose around £40 each and ESA claimants around £50 each.

The **government has promised to reconsider** its controversial decision to scrap a £180m-a-year welfare hardship fund used to provide emergency support for some of England's poorest citizens.

The U-turn follows ministers' unexpected announcement earlier this year that they would abolish local welfare assistance funding in April 2015, just two years after it was introduced as a replacement for the Social Fund.

Liberal Democrat and Labour MPs have joined forces to defeat Conservatives in a Commons **vote to partly overturn housing benefit changes**.

Labour and Liberal Democrat MPs joined up to send the affordable homes bill, sponsored by Andrew George MP, through to a second reading vote by 306 to 231. Seventy Conservative MPs ignored a three line whip and stayed away from Westminster. Angie Bray, Tory MP for Ealing Central and Acton, voted against her party.

Lib Dem MP Andrew George's private member's bill will now move to detailed scrutiny at the committee stage.

Mr George's bill would mean people who could not be found a smaller home would be exempt from the cuts, as well as disabled people who need a spare bedroom or who have adapted homes.

A woman who was worried she would have to move out of her house or pay extra to stay because of the bedroom tax killed herself, a coroner has ruled.

Stephanie Bottrill, 53, had raised a son and daughter in her three-bedroom council house in the West Midlands but was living there alone after her children moved out.

On the day before she died, she told her doctor that she felt she was being pushed into choosing whether to move or to stay and face the prospect of paying extra, the inquest in Birmingham was told.
