#### AUTUMN STATEMENT

Chancellor George Osborne announced the government's Autumn Statement. It contained a range of measures that would continue their "long term plan" of austerity, despite predictions of a budget surplus by 2018-9. The government talked up economic recovery and the opposition response highlighted falling living standards. There was a renewed commitment to a cap on welfare spending and **departmental budgets** are to be cut by a further £1 billion by 2015. DfE, DWP, MoJ, and Communities are among those depts. that will see reductions in spending.

**Tax-free childcare** will be introduced from autumn 2015. The government says it will provide 20% of childcare costs up to £1,200 a year for children under 12. 15 hours per week of free childcare is to be extended to 40% of disadvantaged two year olds by September 2014.

Employers will be helped to receive funding for the training costs of **apprentices** directly through an HMRC-led system to which employers will contribute. £40m will be provided to deliver an additional 20,000 higher apprenticeship starts over the next two academic years.

The government have pledged to increase local authority **Housing Revenue Account** borrowing limits by £150m in 2015-6 and £150m in 2016-7. A £1bn six year investment programme will be introduced to "unlock new large housing sites to support the delivery of 250,000 homes."

The government will establish a framework for the **welfare cap** which will be updated in 2014. At the beginning of each

Parliament, the Chancellor of the day will set the welfare cap for the coming years and ask the House of Commons for its support. The cap will not apply to JSA and JSA-passported Housing Benefit, or to those within the Full Conditionality group of Universal Credit with no net earnings. Osborne said the cut in welfare spending was justified because those in work were seeing their incomes rise more slowly than those on benefits. Julia Unwin from the JRF said "The uprating of benefits by 1% will increase poverty. Poorer people are facing perhaps a decade of destitution, felt by future generations." Labour refused to say whether it would back the three-year squeeze in welfare benefits.

The government will increase activity to recover **benefit debt** owed to DWP, using debt collection agencies with "specialist skills in recovering difficult to collect debt" and will introduce measures to reduce fraud to deliver savings of more than £2.3bn over the forecast period.

There are various gains for current **pensioners**, and a prediction that the retirement age will reach 69 by the 2040s. Public and Commercial Services union general secretary Mark Serwotka argued the age increase would mean "poorer people with lower than average life expectancy will pay for the pensions of the rich." The average age of Conservative voters is 68.

The Statement documents also highlight a plan to recoup £3.5bn in **offshore taxes** but a similar plan to recover tax from Switzerland failed to reach anything near its target (£1.9bn of £5.3bn).

#### **CARE**

The Care Bill had been originally drafted to oblige CQC to conduct regular checks on authority adults' services. local giving ministers the option of reintroducing regular performance assessments and routine checks on commissioning. However, the government has now issued an amendment to repeal this section of the bill. A further amendment would enable the CQC to conduct a "special review" of a local authority with the approval of the secretaries of state for health and local **IPPR** government. The highlight the importance of routine checks on commissioning.

The government has launched a website comparing adult social care between local authorities. **The Adult Social Care Outcomes site** provides data for each area in England on 21 indicators including direct payment take-up rates, the self-reported quality of life of a sample of service users and rates of delayed discharges from hospital attributable to a lack of social care.

Manchester City Council have published their first **Market Position Statement** concerning Adult Social Care, which forms the basis for

future commissioning. It begins with a statement of strategy with emphasis on prevention, personalisation, partnerships and return on investment all in the context of diminishing resources. The main bulk of the document, however, goes through supply and demand in every area of service provision and contains a lot of statistics.

#### **CHILDREN AND FAMILIES**

The government have responded to their **Supporting separated families: securing children's futures** consultation. The Child Maintenance Service (CMS) will take over all new child maintenance cases and the overhaul will see the introduction of charges for both parents if the maintenance-paying parent refuses to pay or arrangements break down. Single parents turning to the CMS to collect child maintenance will result in the child losing on average £70 a year in charges.

The State of Children's Rights in England report accuses the government of using "economic pressures" to "justify not only a serious erosion of children's economic and social rights, such as health, food and the right to play, but also fundamental changes to our justice system." Hundreds of thousands more children are living in poverty compared to a year ago - the total number is predicted to reach 3 million by 2015.

According to research by *Community Care*, three quarters of **Child protection social workers** do not have the time or resources to prevent vulnerable children from coming to serious harm, while child protection ends at 14 in some authorities. The report also finds that protection thresholds have risen over the past year, making it harder for workers to intervene and protect children from neglect and abuse. Budget cuts, rising child protection referrals and social work vacancies were cited as the main causes of rising thresholds.

Unicef UK has partnered with six local authorities in the **Child Rights Partners** project to enlist the help of young people in the design and delivery of services aimed at them. The project will "prioritise the most vulnerable children, including those living in care or poverty and young people affected by drug and alcohol misuse". Each local authority is using the project to deliver different types of service: Tower Hamlets; Derry; Glasgow; Leeds; Neath and Port Talbot; and Newcastle.

#### **CRIMINAL JUSTICE**

The Centre for Social Justice have published The new probation landscape: Why the voluntary sector matters if we are going to reduce reoffending. It looks at reforms to the probation service and seeks to inform "strong and resilient partnerships between the private and voluntary sectors."

#### **DISABILITY**

The Court of Appeal overruled the government's decision to close the Independent Living Fund (ILF). Although the Court upheld the government's position that the consultation exercise on the closure of the ILF was lawful, the Court held that the Minister for Disabled People had breached the public sector equality duty under the Equality Act 2010. Following the judgment, the DWP has instructed the ILF to cease the Transfer Review Programme and all additional closure related activity. The ILF is in the process of writing to all users to explain the position and outline the next steps.

The Shaw Trust, published 'Making Work a Real Choice: Where next for specialist disability employment support?', research that argues there is a strong case for retaining a specialist disability employment programme along the lines of a refined Work Choice model. The report argues that "whilst Work Choice is proving successful in helping disabled people into work, there are a number of improvements that could be made both now and in the development of a future programme." Earlier this year, the government published their own evaluation of Work Choice.

The DWP has announced that £2m has been set aside through the **Access to Work** scheme to help disabled people take up work placements. Before this investment, Access to Work only offered this type of support to disabled people on work experience placements organised through Jobcentre Plus.

A Freedom of Information request by the **Disabled Benefits Consortium** (DBC) revealed that one in five people receiving Disability Living Allowance (DLA) are currently in work. In a survey of over 1,000 disabled people, over half of those receiving in-work DLA said it "could be impossible to stay in work without it". The government's total cut in mobility support for disabled people in work could save £145m but, based on the DBC's estimates, the consequences could cost £464m.

#### DOMESTIC VIOLENCE

The Domestic Abuse Disclosure Scheme ('**Clare's Law**') enables people to check the police record of their partners, and is to cover all of England and Wales following pilots. Home Secretary Theresa May said "The national scheme will ensure that more people can make informed decisions about their relationship and escape if necessary." The House of Commons Library have prepared a Standard Note on the new law which includes arguments for and against it.

#### **EMPLOYMENT**

November's unemployment statistics find that unemployment has fallen by 0.2% (48,000 people). The figures also show that 18.5% of people in part-time work (1.46 million people) are working part-time just because they could not find full-time work. The report highlights the significant gap the 35,000-person fall between in unemployment (excluding young people in full time education) and the 104,000-person fall in benefit claimants. Employment minister Esther McVey welcomed the figures, saying: "This Government is delivering on its promise to rebalance the economy, promote job creation, and support people to get off benefits and into work."

The **living wage**, aimed at meeting basic needs, has increased by 20p an hour, or 2.7%, to  $\pounds$ 7.65 outside London. It is higher than the legal minimum wage, which stands at  $\pounds$ 6.31 an hour for over-21s. The living wage is independently set each year, according to the basic cost of living. It is updated annually and employers choose to pay the rate voluntarily.

The IPPR have also published research into **the cost of low pay**. It estimates that every low-paid worker moved on to the living wage would save the government an average of  $\pounds 232$  in lower social security spending and raise  $\pounds 445$  in higher tax receipts.

The government's **"back to work" schemes** were legally flawed, according to the supreme court. The court ruled against the DWP, which was attempting to overturn an earlier verdict by the court of appeal. The verdict was that the 2011 regulations creating the programme were invalid as they did not contain a sufficiently detailed "prescribed description" of the schemes.

#### <u>HEALTH</u>

Simon Stevens has been appointed **new chief executive of the NHS in England**. Stevens previously advised the New Labour government on 'marketising' the NHS before working for American private health company UnitedHealth. "In the light of NHS spending pressures," he has accepted a salary of £211,000 and the NHS has announced that he will have no official dealings with UnitedHealth for the first 12 months of his appointment. An article in the *Health Service Journal* praises Stevens' 'influence' and 'intellect'.

Appeal court judges upheld a verdict that health secretary Jeremy Hunt's cuts to Lewisham hospital were unlawful. The court took ten minutes to reach the verdict that Hunt's closures of A&E and Maternity at the South London hospital were in breach of the National Health Service Act. Tony O'Sullivan, director of children's services at Lewisham and Greenwich NHS trust said: "We always said they were acting unlawfully and undemocratically in using an emergency process to bypass meaningful consultation and destroy an excellent hospital." The Care Bill (see Care, above) currently going through Parliament, will make challenges like that at Lewisham impossible in the future.

#### HOUSING & HOMELESSNESS

An *Inside Housing* survey of 113 social landlords across Britain reveals that "councils, arm's-length management organisations and housing associations" are increasingly using the **threat of eviction** to protect their income in the face of welfare reform and falling living standards. The survey shows that landlords issued 99,904 notices seeking possession for rent arrears in April to November this year, compared with 79,238 for the same period in 2012 - a 26% increase.

The **Rental Exchange initiative** is a national programme involving Big Issue Invest and credit ratings agency Experian. It will be rolled out next year to improve social tenants' credit ratings, allowing them to access traditional private finance. Experian found that 20% of social tenants fell just below mainstream lenders' pass marks but said adding rental payment data could help one million social tenants.

#### **IMMIGRATION AND ASYLUM**

The government announced **new measures** to prevent immigrants from other parts of the EU from accessing benefits, ahead of the lifting of restrictions on migrants from Romania and Bulgaria in January. The measures include a three-month qualification period for benefits, which would then only be payable for six months. European migrants only working in part-time jobs and falling below a certain income threshold would lose access to some benefits and newly arrived EU jobseekers would not be able to claim housing benefit. Also discussed were new powers to deport European migrants found begging or sleeping rough.

Downing Street says the rules allowing deportation of homeless people and six-month limit on getting jobless benefits would be in force from 1 January, as well as a "tougher" habitual residence test (which determines general eligibility to many UK benefits). The three-month delay on claiming out-of-work benefits will take longer to implement because it requires legislation, while it is not yet known when, and for how long, EU migrants would not be able to claim housing benefits.

However, experts in constitutional law as well as the EU's Employment Commissioner said the plans could not be legally implemented.

The NAO published two reports: Managing government suppliers and The role of major contractors in the delivery of public **services**. The reports call for stricter penalties for poor service and highlight the heavy concentration of government spending with a small number of big suppliers (namely Atos, Serco, Capita and G4S). Central government spent £40bn with private providers in 2012-13, the NAO found, that figure more than doubles when local government and NHS services are included. The report noted that G4S and Atos did not pay any corporation tax in 2012 despite between them benefiting from more than a billion pounds of public sector contracts.

**Personal Independence Payment** (PIP) is being rolled out to existing working-age claimants of Disability Living Allowance as of 28 October 2013. The new benefit includes a new face-to-face assessment and regular reviews. The government estimates that 600,000 fewer disabled people will qualify for PIP by 2018.

The DWP have released statistics on the number Benefit cap: of households capped to September 2013. They show that of the 18,024 households subject to the cap, all but 2% featured children and only 2% more had one child, 43% had five or more children and 26% had four children. This seems to support pre-implementation concerns that the cap would disproportionately affect large families. According to Children & Young People Now, "The figures have stoked concerns that the cap will negatively impact on living standards for some of the poorest children."

In local authorities that made no cuts to the benefit there was a 15% increase in the number of liability orders on the previous year.
