Downing Street Conference

On 3rd March 2015 new measures to tackle child sexual exploitation were announced at a Downing Street summit. The overall package includes the following reforms

- New helpline to report bad practice
- Tackling the culture of denial
- Consequences for those failing to protect children
- Prioritising the prevention of child sexual abuse
- Support for survivors

<u>First Aid Training for Nursery Staff</u> Members

On 12th March, new Government proposals have been announced to require all newly qualified staff with a childcare level 2 and 3 qualification must have an emergency pediatric first aid or full pediatric first aid certificate. The proposals will cover all early years' settings except child minders. The training proposals will be subject to a full consultation during the next Parliamentary session, and are expected to come into effect by September 2015. Legal Highs

March 2015

On 11th March, two groups of 'legal highs' were banned. The stimulant compound drug, 4,4'-DMAR, and the synthetic opioid, MT-45, were

outlawed as Class A substances. Full details can be found at the link below:

April 2015

As of 10th April, 5 substances have been banned for 12 months via a Temporary Class Drug Order. These substances are related to methylphenidate, a Class B drug, and have been banned owing to concerns pertaining to their misuse as new psychoactive substances (Legal Highs). The Advisory Council on the Misuse of Drugs (ACMD) will decide whether these substances should be permanently controlled. Further details can be found at the link below:

EMPLOYMENT

Specialist Employment Support Programme

On 24th March, the Government announced those providers that have been successful in being awarded contracts to deliver the Specialized Employment Support Programme for people with disabilities. The

programme is anticipated to ensure 1,700 disabled people across the country receive work-related support annually. The expectation is that this support will help 1,250 disabled people into jobs over the course of an initial 2 year contract. The support goes live in September 2015

Access to Universal Credit

New regulations came into effect in March, which restrict access to Universal Credit for EU migrants. The impact of these regulations is that under Universal Credit, EU households will not be able to access means-tested benefits in the UK without having previously worked in the UK. Legislation coming into effect on 6 April will require nationals from outside the European Economic Area (EEA) coming to the UK for longer than six months to pay a 'health surcharge' when they make their immigration application. Full details can be found at:

At the end of February a plan was unveiled for devolution of the entire Health and Social Care budget (approx £6billion in 2015-2016) to Greater Manchester.

The devolution will involve the whole of the health and social care system – (the scope below)

- Acute care (including specialized services)
- Primary care (including management of GP contracts)
- Community services
- Mental health services
- Social care
- Public Health

- Health Education
- Research and Development

Health and Social Care (Quality and Safety) Act 2015

On 27th March, The Department of Health announced that **The Health and Social Care** (Safety and Quality) Act (2015) has received royal assent. This Act aims to improve safety and quality of care. The measures introduced include:

- a duty on health and adult social care providers to share information about a person's care with other health and care professionals
- a requirement for Relevant health and adult social care bodies to use a consistent identifier - the NHS Number when processing and/or sharing information about an individual for their direct care

CAMHS Mental Health

In March, a report was released on the work of the Children and Young People's Mental Health Taskforce. The report entitled 'Future in mind: Promoting, protecting and improving our children and young people's mental health and wellbeing'. This report makes a number of proposals the Government wishes to see by 2020. These include:

- tackling stigma and improving attitudes to mental illness
- introducing more access and waiting

- time standards for services
- establishing 'one stop shop' support services in the community
- improving access for children and young people who are particularly vulnerable

SCHOOLS

Mental Health Stigma in Schools

At the end of March, the Department for Education announced an action plan to tackle mental health stigma in schools. This plan consists of the following elements:

 Guidance for schools, which will help schools provide age-appropriate teaching on mental health problems from anxiety and depression to eating disorders and self-harm

- Blueprint for schools on counselling services, developed in conjunction with children and young people, which provides head teachers with practical advice on how to deliver top-quality school-based counselling services that meet the needs of those it intends to support
- Funding injection for voluntary organisations to boost support on offer for young people struggling with mental health - a new funding commitment worth £4.9 million - through the government's voluntary and community sector funding programme

Care Certificate

On 25th March, The Department of Health announced that all new healthcare assistants and social care support workers would be expected to get a **Care Certificate** within 12 weeks of employment. It is awarded to staff in health and care roles who can demonstrate that they meet each of the 15 Care Certificate standards, including:

- · caring with privacy and dignity
- awareness of mental health (including dementia and learning difficulties)
- safeguarding
- communication

infection control
