Main duties of the post

- 3. To participate in local networks and partnerships with relevant organisations from all sectors, and to attend relevant meetings
- 4. To collate information on the needs and interests of the community through a variety of methods and techniques
- 5. To facilitate groups/meetings and training where appropriate
- 6. To develop methods for monitoring and evaluating impact/outcomes of services on the community
- 7. To develop and circulate promotional material and information relevant to the community
- 8. To encourage and enable local people to take part in their local community through volunteering for example
- 9. To effectively recruit, manage and develop volunteers where appropriate
- 10. To encourage community participation wherever possible or relevant
